It is our pleasure to present the Board's 2017 Annual Report for the Cornwallis Police Board. The Board's most important functions are to provide civilian oversight and governance of the Department and work with the Chief Constable to ensure our communities are safe and secure.

MESSAGE FROM THE CHAIR

With yet another year under our belt as the Police Board for the RM of Cornwallis we express our gratitude for the progress we have made. This year several key milestones have been reached. They include building on the decision made in 2016 to move the policing role for the RM to a full time role. This decision has resulted in greater coverage, awareness and enforcement in our communities.

Moving into 2017 the decision was also made to advance the equipment and vehicle dynamics for the policing role within the RM. For the first time ever the staff member for the RM is now able to serve the residents of the RM utilizing a vehicle platform built specifically for the RM's needs. A new Police Service Vehicle purchase occurred after a lengthy process of determining the right unit.

Moving ahead into 2018 holds great promise with the potential of further equipment upgrades as well as new additions such as improved computer gear, a portable traffic speed and safety sign unit and more.

We would like to take a moment to thank outgoing Board Member Maureen Cousineau for her years of diligent service. Maureen was a founding member of the Police Board and we are grateful for the voice she brought to the table on behalf of our community.

We also welcome new board member Reg Atkinson as the provincially appointed board member. Mr. Atkinson brings many years of experience in both business and governance roles which will be invaluable moving forward.

Thank-you to all involved in the board and a special thank-you to our staff member Darwin Drader for his continued diligence in providing quality policing for our RM.
