## **PURPOSE**

The purpose of this policy is to provide that a fee be payable by residents and ratepayers of the Municipality directly benefiting from the provision of dust suppressants on roadways.

# **Policy:**

- 1. That residents and ratepayers requesting that dust suppressants be applied to roadways alongside their property will be required to complete an application requesting that dust control chemical be applied and submit it to the Municipality's administrative office.
- 2. That the application referred to in paragraph 1. of this policy will provide as follows:
  - (a). That the applicant provide his or her name and mailing address and date of application;
  - (b). That the applicant provide details as to the requested location of the dust suppressant;
  - (c). That the applicant will be responsible to pay \$100.00 for a single application of dust suppressant at each site. The application of suppressant shall cover approximately 300 ft. of roadway;
  - (d). That the applicant will submit with the application a cheque or money order made payable to the Rural Municipality of Cornwallis in the amount of the prescribed fee;
  - (e) That the Municipality accepts no responsibility for the effectiveness of the dust suppressant;
  - (f) That the Municipality reserves the right to perform such maintenance procedures as it deems necessary on the treated portions of the roadway.
  - (g) That although the Municipality will attempt to minimize any adverse effect of maintenance operations on the treated portion of the roadway, the Municipality will not accept liability for any restoration required.

# Page two Dust Control

- 3. That with respect to roadways designated by by-law as trucking routes, the application of dust suppressant will be paid for by the Municipality and will be applied at such locations and intervals as the Municipality at its discretion deems appropriate.
- 4. That this policy interprets "roadway" as only those roadways that are under the jurisdiction of the Municipality as outlined within The Municipal Act.
- 5. That this policy shall be known as the Municipality's Dust Control Policy.
- 6. That with respect to roadways that have been rebuilt or upgraded with a base stabilization product in the gravel and or base, the application of dust suppressant will be applied at the discretion of the municipality at ward expense.
- 7. That the Municipality reserves the right to apply a dust suppressant on any roadway. The application shall be at municipal discretion and at ward expense.
- 8. The Municipality applies dust suppressant on portions of the following roadways. This list is not inclusive and may be added to at the discretion of the municipality as per 6 & 7 above.
- Antler
- 17<sup>th</sup> Street East
- 1<sup>st</sup> Street
- Richmond Avenue
- Gray Road
- Waggle Springs / Thompson Road
- Wyton Road
- Patricia Avenue / Baker Road
- Haul Roads
